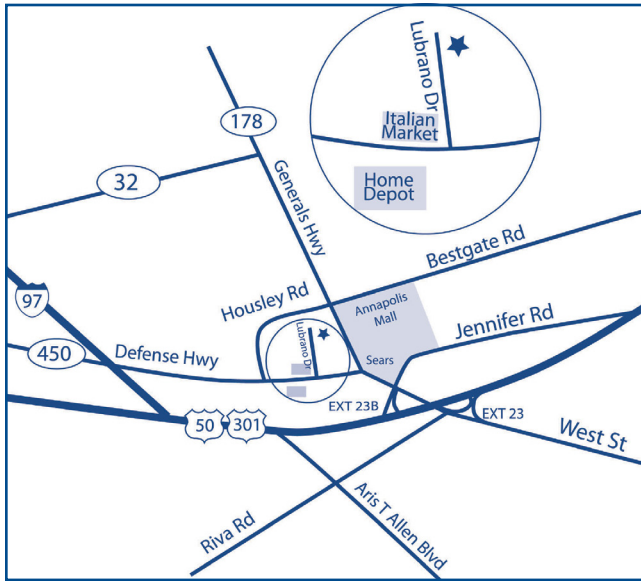

### From Annapolis and the Eastern Shore:

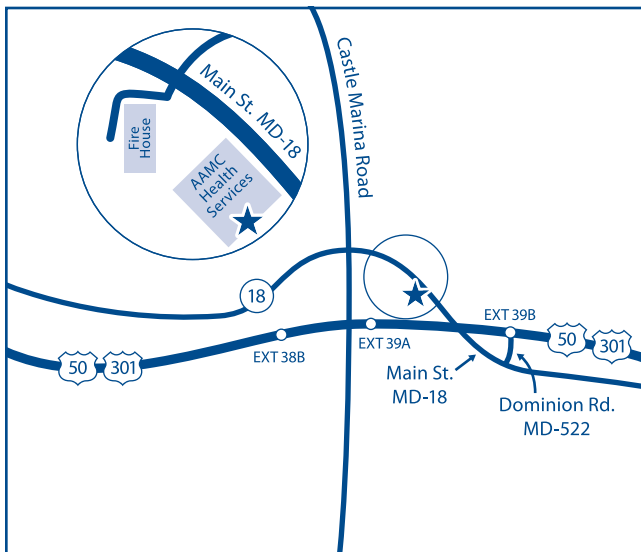
Take Route 50 West to West Street/Parole (Exit 23B). Turn left at light onto West Street (north). Turn left at the first light onto Defense Hwy./Rte. 450 (same road). Proceed 1/4 mile and turn right onto Lubrano Drive, behind the Italian Market. We are straight ahead on the right.

### From Washington DC:

Take Route 50 East to Parole exit (Exit 23). Proceed right off the exit onto West Street. Proceed 1/4 mile north. Turn left on Defense Hwy./Rte. 450 (same road). Proceed 1/4 mile and turn right onto Lubrano Drive, behind the Italian Market. We are straight ahead on the right.

### From Baltimore:

Take I-97 South to Route 50 East. Parole exit (Exit 23). Proceed right off the exit onto West Street (north under Route 50). Turn left on Defense Hwy./Rte. 450 (same road). Proceed 1/4 mile and turn right onto Lubrano Drive, behind the Italian Market. We are straight ahead on the right.

### From Points East of Kent Island:

Take Route 50 West to Castle Marine Road (Exit 39A). The McDonalds is on your right as you take this exit. Travel straight ahead for 1/4 of a mile to the first intersection (which is a traffic circle) make a right turn. You will see the Queen Anne County Fire House on your right, make that right turn at the Fire House and we are straight ahead.

### From Points West of Kent Island including Washington DC and Annapolis:

Take Route 50 East to MD-522 which is S/Dominion Road Exit (Exit 39B). Make a right turn onto Main Street, travel straight ahead over the bridge, continue traveling 4/10 of a mile, the Queen Anne County Fire House will be on your left. Make a left turn at the Fire House and we are straight ahead.

### From Baltimore:

Take I-97 South to Route 50 East. Take MD-522 S/Dominion Road Exit (Exit 39B). Make a right turn onto Main Street, travel straight ahead over the bridge, continue traveling 4/10 of a mile, the Queen Anne County Fire House will be on your left. Make a left turn at the Fire House and we are straight ahead.
